

TERMS AND CONDITIONS of the Special by Gerchik & Co

1. Purpose of the Special and its general provisions

- 1.1. These Terms and Conditions of the Special hosted by Gerchik & Co (hereinafter referred to as the "Terms and Conditions"), which are drawn up and approved by Gerchik & Co Ltd. (hereinafter referred to as the "Company") as part of the relevant Special (hereinafter referred to as the "Special"), shall set out the procedure for participation in the Special and the terms and conditions on which the Company determines the winners thereof and apply to all persons who are indicated by the Company as participants of the Special (hereinafter referred to as the "Participants").
- 1.2. The purpose of this Special shall be to randomly select—in the order of the corresponding monthly draws—3 (three) registration numbers of the Participants of the Special among all the registration numbers of the Participants of the Special. The winners shall be the Participants whose registration numbers are determined during the above monthly draws.

1.2.1. Participants, who have:

- a. registered on the official website of the Company
- b. successfully passed the verification procedure
- c. topped up their Client Account for USD 100 or more (or the relevant equivalent of this amount in EUR) through one or several transactions

during one of the calendar months of the Special's duration, shall be allowed to participate in the Special.

- 1.2.2. The Participants shall have a chance to receive the following prizes: three deposits for USD 100 (one hundred) each, which the Company shall credit to the Client Accounts of those who win the Special as prize amounts, enabling them to use these funds to make trades and earn a profit, without having the right to withdraw their prize amounts.
- 1.3. The Participants of the Special shall acknowledge these Terms and Conditions as the only official document governing the Special and comply with these Terms and Conditions.



1.4. These Terms and Conditions shall be published on the official website of the Company at https://gerchik.co/en and shall be in the public domain. Each Participant of the Special shall be deemed to be fully aware of these Terms and Conditions and may not claim otherwise when participating in the Special. If the Participant disagrees with these Terms and Conditions and is unwilling to participate in the Special, the Participant shall send the Company an appropriate refusal, whereupon the Company decides to deprive such Participant of the status and right to participate in the Special.

2. Procedure of the Special

- 2.1. The Company shall set the following period during which the terms and conditions for participating in the Special are met: from 12:00 a.m., the Company's server time, on the first day of each calendar month to 11:59 p.m., the Company's server time, on the last day of each calendar month.
- 2.1.1. July 2022 shall be the first month to meet the terms and conditions of the Special.
- 2.1.2. The first draw pursuant to Clause 1.2. of these Terms and Conditions shall be conducted in August 2022 based on what financial results the Participants of the Special deliver during July 2022.
- 2.2. The prize pool of this Special shall be formed exclusively at the expense of the Company.
- 2.3. Only those Company's clients who have deposited the appropriate amount to their Client Account opened with the Company by making one or more deposit transactions according to the procedure established by the Company, during each period when the terms and conditions for participation in the Special are met according to Clause 2.1 hereof as well as complied with other requirements stipulated herein, shall automatically become the Participants of the Special.
- 2.4. Subject to the fulfillment of all the requirements outlined in Clause 1.2.1 of these Terms and Conditions, each Participant of the Special shall be assigned one registration number as the Participant of the Special.



3. Procedure for determining the winners of the Special and the terms and conditions for accrual of prize amounts

- 3.1. To provide the prize amounts specified in Clause 1.2.2 of these Terms and Conditions, the winners shall be determined from the total number of the Participants of the Special during the first week of each new month following each month of the Special. A video recording of the process during which the winners of the Special are determined shall be published on the official website of the Company.
- 3.2. The results of the draws hereunder, indicating the winning registration numbers, shall be published on the official website of the Company. The winners of the Special shall be additionally notified by the Company via email indicated during the registration at the official website of the Company, and/or in any other way at the discretion of the Company.
- 3.3. The prize amounts shall be credited to the winners' Client Accounts opened with the Company within 5 (five) business days following the day of the draw.
- 3.4. All of the winners of this Special shall fully consent to the publication of their first name, patronymic, and last name on the official website of the Company.

4. Special terms and conditions for those who win the additional draw

4.1. The prize amounts provided to the winners of the draw by the Company shall be automatically deducted in favor of the Company if no trades have been made within 3 (three) months from the date on which the prize amount is provided by the Company.

5. Final provisions

5.1. The Company shall be entitled to make any amendments and/or modifications to these Terms and Conditions at its sole discretion. Such amendments and/or modifications shall come into force from the moment they are published as an updated version of these Terms and Conditions, as a result of which all the Participants of the Special shall be deemed duly notified by the Company immediately upon introduction of the above amendments and/or modifications to these Terms and Conditions.



- 5.2. The Company shall be entitled to deprive any Participant of the Special of the "Participant" status should the Participant in question violate these Terms and Conditions and/or do any other improper acts during the Special/draw. If such a decision is made, the Company shall be entitled not to notify the Participant thereof and not explain the reasons that led to it.
- 5.3. The Company shall be entitled to change the prize amount for the Special, both increasing and decreasing it. The same shall apply to any terms and dates specified in these Terms and Conditions.
